

Press the shock button (s) for 2 seconds under shock mode. the 4 icon will flash, which means the shock intensity is adjustable. press the (()) to set 1-9 levels.



Press (④) button for 2 seconds again to return to sensitivity level adjustment.

#### Operating Principle

Sound Mode:

- 1<sup>st</sup> blow: 1.5s beep
- 2<sup>nd</sup> blow: 2.5s beep
- 3<sup>rd</sup> blow 7<sup>th</sup> blow: 5s beep
- 8<sup>th</sup> blow: Sleep Mode for Safety (for 75 seconds)

Vibration/Shock Mode:

- 1<sup>st</sup> blow : 1.5s beep;
- 2<sup>nd</sup> blow: 2.5s beep;
- 3<sup>rd</sup> blow: 5s beep, then 1s vibration/shock:
- 4<sup>th</sup> blow: 5s beep, then 1.5s vibration/shock;
- 5<sup>th</sup> blow: 5s beep, then 2s vibration/shock:
- 6<sup>th</sup> blow: 5s beep, then 3s vibration/shock;
- 7<sup>th</sup> blow: 5s beep, then 4s vibration/shock:
- 8<sup>th</sup> blow: Sleep Mode for Safety (for 75 seconds)

Each bark should be within 40 seconds. If the barks interval time exceeds 40 seconds, the device will revert to correction level 1.

#### Test shock function

Current Shock Level <

1). Press the shock button to set the device under shock mode. 2) Blow into the hole of the bark collar three times.

3) Put the Test Bulb Tool on the metal probes of the bark collar, if the test light is on, it means it is delivering the shock.

4) Press the "O" button to adjust the shock strength.

2. The collar should be positioned snugly around your dog's neck

Fitting the Collar to Your Dog

Note: Choose the correct Metal Probes that suit the length of your dog's hair or fur. If your dog has long hair or a thick coat, use the Longer Metal Probes.

- · When possible re-position the collar on the dog's neck every 1 to 2 hours.
- Check the fit to prevent excessive pressure: follow the instructions in this manual.
- Never connect a leash to the electronic collar: it will cause excessive pressure on the contacts.
- · Wash the dog's neck area and the contact probes of the collar weekly with a damp cloth.
- Examine the skin contact area daily for signs of a rash or a sore. If a rash or sore is found, discontinue use of the collar until the skin has healed. If the condition persists beyond 48 hours, see your veterinarian.
- This product comes with two pairs of plastic contact points, use the suitable size to fit your dog's fur. Bark collar meets IP3 waterproof rating. It is protected
- against splashing/spray
- These steps will help keep your dog safe and comfortable. Some dogs are sensitive to skin contact pressure. You may find after some time that your dog is very tolerant of the collar. If so, you may relax some of these precautions.

- It is important to continue daily checks of the skin contact area. If redness or sores are found, discontinue use until the skin has fully healed.

Product Functionality

This Anti Bark Collar helps prevents your dog from barking through the humane application of a behavior-modifying single beep, combination of beep and vibration or combination of beep and mild shock

#### Main Features


- LED indicator lights
- Digital display for different sensitivity levels and shock strength levels
- 7 sensitivity levels for different dogs (level 1 is the lowest, level 7 is the highest).
- 9 shock strength levels for different dogs (level 1 is the lowest. level 9 is the highest)
- 7 beep levels for different dogs (level 1 is the lowest, level 7 is the highest).
- 3 alternative working modes (beep, beep + vibration, beep+shock).

#### Charging Instructions

- Charge the Anti Bark Collar before use.
- 1. Charge only with specified charger.
- 2. When the battery bars are running, the product is charging. 3 static bars means the product is fully charged.
- 3. 4 levels of battery display:





Note: We suggest to charge the device when the battery is below 50%.

#### Operation Instructions

- Press the Power button ((()) for 2 seconds to turn the collar on. Then press this button for 1 second to choose different sensitivity
- levels (from 1-7).
- Press the sound buttont ( 1) to set this device in beep mode. Press the vibration button ( ()) to set this device in beep+vibration mode. Press the shock button ( ()) to set this device in beep+shock mode.

### CAUTION!

- You should train your dog with some commands (such as

### FAQs

#### Q: What kind of dogs are the collars suitable for?

A: The collar is adjustable in length from 9.5 to 26 inches. If your dog's neck is smaller than 26 inches, please cut the redundant part.

#### Q: My dog barks, but the collar isn't activated

A: The collar battery may be running low, please charge it. Please ensure to fit the product snugly, yet loose enough to allow one finger to fit between the strap and your dog's neck. Some dogs have weak barking, in this case you will need to increase the sensitivity level. Thicker coating on the neck area may also decrease the sensitivity of the collar from barking. If necessary, trim the coat near the area where you place the product.

#### Q: Is the bark collar waterproof?

A: It is waterproof, such as walking on a rainy day, but you must seal the charging port tightly and keep it dry if it gets wet.

#### Q: Can I attach a leash to the collar?

A: No. This will result in the metal probes being pulled too tightly against your dog's neck. If you need to put a leash on your dog, put a seperate NONMETALLIC collar on your dog's neck first.

Q; Can I charge this product with any type of charger? A: No, we recommend to use a charging adapter rated at 5V/500-1000mA because a charging adapter rated at 9V or 12V

#### may damage to your device.

Q: How do I know if I can use this product on my pet? A: The product is designed for healthy dogs over 6 months old weighing no less than 8 lbs. Most importantly, the product can not be used on unhealthy or aggressive dog. If you are unsure whether this product is appropriate for your pet, consult your veterinarian or a certified trainer.

#### Q: Can I used this product when there are other dogs playin around?

A: Dogs will bark when playing and get excited, for the comfort and safety of your pet, we do not suggest using this product in such an environment

#### Q: Why is the product triggered sometimes in a noisy environment thought the dog isn't barking?

A: Even though we have optimized the barking detection, some environment noises may have a similar frequency of a barking dog which may potentially activate the product. In this case lowering the sensitivity level can eliminate this.

#### Q: Is the bark Control Collar safe and humane?

A: Yes. The Bark Control Collar is designed to get your dog's attention, not to punish them. However, the initial static shock correction may startle your dog.
