
# **Assembly Instructions for Model 130**


### **IMPORTANT INFORMATION!**


- 1. If you discover any parts are missing, immediately call our toll-free service helpline at 1-800-428-8560.

- 3. You will need a phillips head screwdriver for assembly.


## **Parts Identification**













Plastic Caster Plate (4) - Used to attach the casters.

Steel Caster Plate (4) - Used to attach the casters.

Nuts & Bolts (16 sets) - Used to attach the casters.









## **Assembly Instructions**


Note: Although it can be assembled by one person, due to the size, you may find it easier to assemble with 2 able people.

Lay Cat Playpen on floor. Separate all parts. Remove all wires used to bundle the cage together. Unfold cage by lifting both side and end panels upright one section at a time.


Secure the sides to the ends by lifting the end panels into the corner locks located on the side panels.

When all sides are secure, swing the top panel over and secure all the hooks on the top panel to the top wires of the corresponding sides.










- With the doors securely latched, tip the assembled playpen on the side to attach the casters. Locate the Casters, Plastic Plates, Steel Plates and the Nuts & Bolts.
- The casters will be place in the four corners of the base at 2 intersecting wires.

Place the Plastic Plate on the bottom of the intersecting wires so the bottom wire fits in the "channel." Put the Steel Plate on the top

so the wire fits in the "channel." Put the Caster up against the Plastic Plate so all the holes line up.

Insert a bolt in each hole and secure it with a nut.



Carefully set the Playpen upright on the casters. Locate the Shelves and the bed.

Attach the bed to one of the shelves by looping the Velcro strip through the wire in the corner of the shelf and securing it on the under-side of the bed.




Open the doors and install the shelves by placing the hook on the far side over a wire and then hooking it on the front of the playpen. Be sure that the side of the shelf with the hooks closest to the edge are positioned to the outer side of the Playpen.

Slide the Plastic Pan in through the opening at the bottom of the playpen. Secure the pan in place with the wire pan stop.



### LIMITED MANUFACTURERS WARRANTY

- A. The purchaser must call MIDWEST's HELPLINE, 800-428-8560, to report the alleged defect to a customer service representative or obtain missing parts.
- B. The customer service representative will determine if the defect is covered by this warranty, and if it is, will authorize and instruct the purchaser in how to obtain corrective action.
- C. MIDWEST may require the purchaser to present the sales receipt or other proof of purchase prior to authorizing any return or replacement. No returns or replacements will be permitted without proper authorization. If a return or replacement is authorized, you may be requested to return the item to MIDWEST or to make the item available for pick-up by MIDWEST.
- 4.
